**SUBJECT: AUTHORITY TO CONDUCT THE BFAR- SPECIAL AREA FOR AGRICULTURAL DEVELOPMENT (SAAD) PUBLIC RELATIONS AND DEVELOPMENT COMMUNICATION (PRDC) TRAINING**
