**SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE FY 2023  
MID-YEAR ASSESSMENT OF FARM-TO-MARKET ROAD  
DEVELOPMENT PROGRAM (FMRDP)**
