SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE PHILGAP TRAINING FOR PROVINCIAL AGRICULTURISTS AND CITY/ MUNICIPAL AGRICULTURISTS OF LOCAL GOVERNMENT UNITS
