SUBJECT

AUTHORITY TO CONDUCT THE INDIGENOUS PEOPLES SECTORAL COUNCIL (IPSC) 2^{ND} QUARTER 2023 COUNCIL MEETING AND LUZON-WIDE BASIC PARALEGAL TRAINING IN THE NATIONAL CAPITAL REGION

Pursuant to Republic Act 8425, the National Anti-Poverty Commission (NAPC) is mandated to ensure the participation of the basic sectors in addressing social reforms and poverty alleviation programs. The Indigenous Peoples Sector (IPS), being one of the identified basic sectors represented in RA 8425, the NAPC is hereby authorized to conduct the Luzon-wide Basic Paralegal Training on June 27-29, 2023 and the Indigenous Peoples Sectoral Council (IPSC) 2nd Quarter Council Meeting on June 30-July 1, 2023 in National Capital Region (NCR).

The training aims to provide participants with basic and practical knowledge of substantial legal concepts, particularly on the provisions of the Indigenous Peoples' Rights Act (IPRA) as well as the titling process of ancestral domains/lands and tenurial instruments. Meanwhile, to be discussed during the annual meeting are updates concerning the sector's priority sectoral agenda on the delineation and registration of CADTs, selection and appointment of IPMRs, and the proposed ratification of ILO 169.
