SUBJECT: AUTHORITY TO PARTICIPATE IN THE INTERNATIONAL ATOMIC ENERGY AGENCY (IAEA) REGIONAL TRAINING COURSE ON RISK-BASED DRUG RESIDUE MONITORING IN FOOD
