- SUBJECT: REGIONAL SUPPLEMENTAL GUIDELINES TO MEMORANDUM CIRCULAR NO. 08 SERIES OF 2023, OTHERWISE KNOWN AS THE "AMENDMENTS TO MEMORANDUM CIRCULAR NO. 25 SERIES OF 2022, CONSOLIDATED GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY-BASED SWINE PRODUCTION, REPOPULATION AND EXPANSION UNDER THE INTEGRATED NATIONAL SWINE PRODUCTION INITIATIVES FOR RECOVERY AND EXPANSION (INSPIRE) PROGRAM"

The Regional Supplemental Guidelines for Region 10 shall provide for the following amendments to Memorandum Circular No. 8, Series of 2023, a directive providing for the amended guidelines for the implementation of Integrated National Swine Production Initiatives for Recovery and Expansion (INSPIRE) Program of the National Livestock Program (NLP), specifically on the provisions involving external stakeholders as partner implementers, to wit;

"Section V.C.b. Responsibility of DA Regional Field Office, shall be amended as follows:

v. Assist the qualified **FCAs/LGUs** upon request for the preparation, planning implementation, and supervision of the project specifically managing the funds for the construction of the Bio-secure Facility and procurement of necessary equipment.

On the other hand, the Regional Field Office may opt to procure all the project components for non-CSO Accredited FCAs and/ or LGU subject to RA 9184.

"Section VI. A Recommended Project Package, shall be amended as follows:

1. FCA/LGU without Existing Facilities

This scheme is for qualified FCA/LGUs (see Section VII) which opt to establish a new facility. Qualified beneficiaries may choose between the two options listed below. The recommended allocation for the funding coverage under FCA/LGU without existing facilities are as follows:

Option 1

"Section VII. Minimum Requirement shall be amended as follows:

The minimum Project package as stated in Section VI can be availed by organized active FCAs and Local Government Units (LGUs) who desire to undertake modernized swine raising compartments using the community swine clustering model. The number of target clusters for **LGU-recipients may exceed 20%** of the total target number of clusters as indicated in the regional work and financial plan.

The following qualifications must be considered:

2. LGU Applicants

- 1. Must have existing BABay ASF-related Ordinances/Executive Orders Compliant with the protocols under the DA Administrative order No. 30 series of 2021;
- 2. Must be released from ASF quarantine (if applicable);
- 3. Must be willing to provide the land, maintenance and labor, and shoulder other costs incurred beyond the implementation of the projects as its counterpart;
- 4. The LGU may distribute the offspring to the qualified FCAs/barangay units in order to augment the supply of hogs and pork in the locality;
- 5. Ensure the sustainability of the project.

This order shall take effect immediately and supersede all other issuances inconsistent hereof.
