SUBJECT : AUTHORITY TO CONDUCT THE NATIONAL CAPACITY BUILDING ACTIVITY ON THE IMPLEMENTATION OF THE DA-DENR JOINT ADMINISTRATIVE ORDER (JAO) 2021-01 ON MAINSTREAMING BIODIVERSITY-FRIENDLY AGRICULTURAL PRACTICES (BDFAPs) IN PROTECTED AREAS AND WIDER AGRICULTURAL LANDSCAPES

The Department of Agriculture Policy Research Service is hereby authorized to conduct the National Capacity Building Activity on the Implementation of the DA-DENR Joint Administrative Order 2021-01 on Mainstreaming Biodiversity-friendly Agricultural Practices in Protected Areas and Wider Agricultural Landscapes (BDFAP-JAO) scheduled in **September 2023 at the International Institute of Rural Reconstruction (IIRR), Silang, Cavite.** The IIRR is one of the accredited facilities of Agricultural Training Institute.

Pursuant to Section 10 (National and Regional Technical Support) of the BDFAP-JAO, the DA and DENR shall create an oversight committee at the national level and a regional technical working group to execute the provisions outlined in the BDFAP-JAO.

In view of this, the activity aims to capacitate the members of the NOC and RTWG on BDFAPs, particularly on the implementation of activities and strategies under the proposed six-year implementation plan.
