### SUBJECT : COMPOSITION OF THE JOINT TECHNICAL WORKING GROUP ON THE OPERATIONALIZATION OF MEMORANDUM ORDER (MO) NO. 19, SERIES OF 2023

To effectively operationalize the provisions of the Memorandum Order No. 19, series of 2023, Functional Complementation and Collaboration between and among the Bureau of Agricultural and Fisheries Engineering (BAFE), DA National Livestock Program (NLP), and Agricultural Training Institute - International Training Center on Pig Husbandry (ATI-ITCPH) on the Planning, Provision, and Implementation of Agricultural Machinery, Equipment and Facilities in the National Livestock Program, the following shall compose the Joint Technical Working Group (Joint TWG):

## **II. FUNCTIONS**

. . . .

### A. DA-NLP

- 1. Include the abovementioned undertakings in the preparation of the DA-NLP Plan and Budget Proposals for FY 2024 onwards;
- 2. Mobilize the support of the regional livestock focal persons in the implementation of the identified collaboration areas in coordination with the DA-RFO RAEDs; and
- 3. Coordinate and spearhead the conduct of consultation meetings and workshops with the private sector.

#### **B. BAFE**

- 1. Spearhead the formulation of Livestock and Poultry Mechanization and Infrastructure Plan 2023-2028;
- 2. Develop guidelines and policies to support the planning, implementation, and operation and maintenance of engineering-related programs and projects of the DA-NLP;
- 3. Assist DA-NLP in the establishment/strengthening of livestock mechanization and infrastructure management information system;
- 4. Develop and/or update modular designs and technical bulletins of livestock and poultry machinery, equipment, and facilities;
- 5. Review and recommend technical specifications of machinery and equipment; and
- 6. Identify and endorse livestock machinery and infrastructure standards to BAFS for standards development and undertake its enforcement and other regulatory activities on livestock and poultry mechanization and infrastructure.

## C. ATI-ITCPH

- 1. Fund and conduct trainings for the ABEs in the DA and LGU on emerging technologies and innovations in livestock machinery and infrastructure development;
- 2. Collaborate with BAFE in the formulation of Livestock and Poultry Mechanization and Infrastructure Plan 2023-2028; and

3. Coordinate with TESDA and BAFE in developing and rolling out Training Regulations on the operation of various livestock machinery and equipment.

## D. JOINT TWG

1. Coordinate, consult, and collaborate with the PHilMech, BAI, NMIS, PCC, NDA, DA Regional Field Offices, and other agencies in the implementation of the above undertakings.

The expenses to be incurred in the conduct of activities, such as, but not limited to workshops, meetings shall be chargeable to the funds allocated to the DA-NLP. Moreover, the travelling expenses and per diem incurred by the Joint TWG Members shall be chargeable to the regular funds of their respective offices subject to the usual government accounting and auditing rules and regulations.

This order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
