II. FUNCTIONS

1. Conduct site validation, prepare pre-engineering documents, and provide technical assistance on the implementation of livestock mechanization and infrastructure projects;
2. Spearhead the formulation of *Regional Livestock and Poultry Mechanization and Infrastructure Plan 2023-2028*; and
3. Provide necessary inputs on the development and/or updating of modular design and technical bulletins of livestock and poultry machinery, equipment, and facilities.

The expenses to be incurred in the conduct of workshops, travelling expenses, and per diems of the DA-RFO RAED personnel while performing the abovementioned functions shall be charged to the regular funds of their respective Regional Livestock Programs subject to the usual government accounting and auditing rules and regulations.

This order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
