SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE ACTIVITIES FOR THE OBSERVANCE OF THE NATIONAL INDIGENOUS PEOPLES DAY AND 5TH ANNIVERSARY OF THE DA-4K PROGRAM

Pursuant to Republic Act No. 10689, "Declaring August 9 as National Indigenous Peoples Day and Mandating the Meaningful Observance Thereof", the DA 4K – National Program Management Office (NPMO) is hereby authorized to conduct activities for its meaningful observance and the 5th Anniversary of the DA-4K Program on August 9-11 and 15, 2023 in the Department of Agriculture-Central Office. This year theme is "Indigenous Youth as Agents of Change for Self-determination".

The celebration will feature the culture and tradition of our Indigenous Peoples in the Philippines and will be conducting a training that will focus on orienting the DA Offices on Cultural Sensitivity and other relevant topics for Indigenous Peoples on 9th day of August 2023 at DA Conference Room and an exhibit at the DA Lobby on 9-11 August 2023 and thanksgiving mass at the DA-4K Program Office on August 15, 2023.

This is an opportune time to increase public awareness and advance efforts to recognize, promote, protect, and fulfill the rights and well-being of the Indigenous Cultural Communities and Indigenous Peoples.
