**SUBJECT : AUTHORITY TO CONDUCT THE FARMERS AND FISHERFOLK ENTERPRISE DEVELOPMENT INFORMATION SYSTEM (FFEDIS) ASSESSMENT AND PLANNING WORKSHOP IN TAGAYTAY CITY ON OCTOBER 3-6, 2023**

In the interest of service, the Department of Agriculture – Agribusiness and Marketing Assistance Service (DA-AMAS) is hereby authorized to conduct an Assessment and Planning Workshop on October 3 to 6, 2023 in the Development Academy of the Philippines in Tagaytay City, Cavite.

The activity aims to:
