SUBJECT: AUTHORITY TO CONDUCT REVIEW ON THE INTEGRATION OF SECTORAL CONCERNS IN THE I-REAP AND I-BUILD PLANS OF PRDP

To ensure that sectoral concerns such as gender sensitivity, disability, senior citizens, and youth are incorporated in the project cycle of PRDP Components, the National Project Coordination Office of PRDP (NPCO-PRDP) is hereby authorized to conduct, REVIEW ON INTEGRATION OF SECTORAL CONCERNS IN THE I-BUILD AND I-REAP PLANS OF PRDP on August 22-25, 2023 in Region IVA.

This activity aims to:
