SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE WORKSHOP ON THE ASSESSMENT ON THE IMPLEMENTATION OF QUALITY PROCEDURES RELATIVE TO ORGANIC AGRICULTURE REGULATIONS

In the interest of service and to enhance the delivery of service and personnel performance in view of Ease of Doing Business and Efficient Delivery of Government Services, the DA-Bureau of Agriculture and Fisheries Standards (DA-BAFS)- Organic Agriculture Division (OAD) is hereby authorized to conduct and attend the Workshop on the Assessment of the Implementation of Quality Procedures Relative to Organic Agriculture Regulations in Cagayan De Oro City, Misamis Oriental in October 2023.

The workshop aims to improve and/or enhance the procedure on the following OAD processes:

1. Accreditation of PGS Groups as OCB;
2. Inspection and certification of five core farmer-members;
3. Monitoring of certified farms under the PGS scheme;
4. Provision of technical assistance relevant to organic agriculture regulations; and
5. Handling complaints and appeals for inspection and certification issues.
