## SPECIAL ORDER No.: 1076 Series of 2023

## SUBJECT : AUTHORITY TO CONDUCT "TRAINING OF TRAINERS (TOT) ON CACAO PRODUCTION, FERMENTATION, DRYING, AND BEAN GRADING" FOR THE CACAO-SUPPORTED PROPONENT GROUPS OF PRDP I-REAP

In the interest of service and as part of the continuous provision of technical assistance to the project beneficiaries, the Philippine Rural Development Project - Enterprise Development Component, National Project Coordination Office (PRDP - I-REAP, NPCO) is hereby authorized to conduct **Training of Trainers (ToT) on Cacao Production, Fermentation, Drying, and Bean Grading for the Cacao-supported Proponent Groups of PRDP-I-REAP** in five (5) batches on schedules as shown below. The training shall be conducted in collaboration with the Philippine Cacao Industry Association, Incorporated (PCIA, Inc.), Philippine Cacao Industry Council (PCIC), Department of Agriculture-Agricultural Training Institute (DA-ATI), and University of Southern Mindanao (USM).

The training aims to develop the knowledge and skills of the Proponent Groups (PGs), partner implementers, and individual farmers on good agricultural practices for cacao to improve quality and generate higher incomes. Specifically, it aims to: a.) enhance the knowledge and skills of cacao farmer beneficiaries on proper cacao production management protocols; b.) develop cacao trainers and cascade the same modules to the members of the proponent groups to achieve a wider reach of farmers in practicing the appropriate practices; c.) provide an experiential method of learning and adoption of farming practices and technology for coffee farmer beneficiaries and project implementers and; d.) capacitate the farmers to qualify and enter local or international cacao competition to add more value for their cacao beans.
