## SUBJECT: AUTHORITY TO CONDUCT SITE VALIDATION AND PREPARATORY ACTIVITIES FOR THE ESTABLISHMENT OF EDIBLE GARDEN AND AGRI-TOURISM SITE IN BUCOR IWAHIG, PALAWAN

In view of the partnership between DA and DOJ for the **Reformation Initiative for Sustainable Environment for Food Security (RISE) Project,** the Edible Landscaping team of the University of the Philippines Los Baños (UPLB) is hereby authorized to conduct site validation and other preparatory activities with the National Urban and Peri-Urban Agriculture Program (NUPAP), at Iwahig Prison and Penal Farm, Puerto Princesa City, Palawan.

The Edible Landscaping Team of UPLB and the NUPAP Program Management Office (PMO) shall be able to:

- 1. Craft detailed design for the establishment of edible landscaping and agritoursim site;
- 2. Equip the Persons Deprived of Liberty (PDLs) of BuCor Iwahig with skills on the proper establishment, maintenance, plant care, and post-harvest handling activities for the edible garden; and
- 3. Prepare the materials needed for the implementation of the Edible Garden as part of the RISE for Food Security Project.
