SUBJECT : AUTHORITY TO CONDUCT THE WORKSHOP ON THE FINALIZATION OF THE TECHNICAL SPECIFICATIONS OF ANIMAL HAULING TRUCK AND THE ENGINEERING DESIGN OF SWINE FACILITY WITH 100-HEAD CAPACITY UNDER THE INSPIRE PROGRAM FOR CY 2024

In the interest of the service, the National Livestock Program in collaboration with the Agricultural Training Institute – International Training Center on Pig Husbandry (ATI-ITCPH), is hereby authorized to conduct the **Workshop on the Finalization of the Technical Specifications of Animal Hauling Truck and Engineering Design of Swine Facility with 100 Head Capacity** on **August 7-11, 2023**, in **ATI-ITCPH, Brgy. Marawoy, Lipa City, Batangas**.

The activity aims to finalize the technical specification of the animal hauling truck to be provided to the beneficiaries of INSPIRE Program in CY 2024 as well as to finalize the Detailed Engineering Design (DED) and Program of Works (POW) of the 100-head Capacity Swine Facility.

The authorized participants of the workshop are selected staff from the National Livestock Program – Program Management Office (NLP-PMO), Bureau of Agricultural and Fisheries Engineering (BAFE), and one (1) Focal Person for Livestock Engineering from each of the DA-RFOs (designated as per Special Order No. 866 Series of 2023.
