AUTHORITY TO CONDUCT THE JUDGING AND AWARDING CEREMONY OF THE NATIONWIDE ON-THE-SPOT POSTER MAKING CONTEST FOR THE WORLD FOOD DAY CELEBRATION

The Department of Agriculture in partnership with the Food and Agriculture Organization of the United Nations leads the annual celebration of the World Food Day (WFD) held every October of the year. This year's theme is "Water is life, water is food. Leave no one behind."

One of the highlights of the activities in the WFD celebration is the On-the-Spot Poster Making Contest. This is conducted in coordination with the Department of Education (DepEd). The contest is participated in by elementary grade pupils, Grades V and VI from public schools and/or DepEd accredited private elementary schools nationwide.
