SUBJECT: AUTHORITY TO CONDUCT STAKEHOLDERS' BRIEFING/ CONSULTATION FOR THE DOMESTIC ACCEPTANCE OF THE WORLD TRADE ORGANIZATION – FISHERIES SUBSIDIES AGREEMENT

In accordance with our international engagement, particularly in the World Trade Organization for domestic acceptance of the WTO – Fisheries Subsidies Agreement, and due to the urgency of the service, the Bureau of Fisheries and Aquatic Resources is granted authorization to conduct the aforementioned activities in a privately-owned facility with function hall and room accommodation within Quezon City, on 31 August 2023.

The one (1) day stakeholders' consultation is authorized to be participated by 100 participants, comprising 30 live-out and 70 live-in participants—staying for 2 nights. The participants will include:


