SUBJECT : CREATION OF A TECHNICAL ADVISORY COMMITTEE (TAC) FOR THE DESIGN AND ESTABLISHMENT OF PERFORMANCE CRITERIA OF SINGLE CYLINDER GASOLINE ENGINE

The project, "Design and Development of Single Cylinder Gasoline Engine" currently implemented by the Philippine Center for Postharvest Development and Mechanization (PHilMech) aims to locally develop a single cylinder gasoline engine to reduce dependence on imported engine and spare parts and create employment opportunities in the local agricultural machinery manufacturing sector and a potential export to foreign markets.
