AUTHORITY TO CONDUCT "TRAINING ON I-REAP PROCESS, BUSINESS

MODELLING, BUSINESS PLAN PREPARATION, APPRAISAL AND

EVALUATION"

In the interest of service and as part of the mainstreaming activities, the Philippine Rural Development Project (PRDP) – Investments for Rural Enterprise and Agricultural and Fisheries Productivity (I-REAP), is hereby authorized to conduct the activity: **Training on I-REAP Process, Business Modelling, Business Plan Preparation, Appraisal and Evaluation** to be held on **August 29 - September 1, 2023 in Region 4-A.**
