**SUBJECT** 

AUTHORITY TO CONDUCT TECHNICAL TRAINING TO APTC/PTP OPERATORS, FCAS/FARMERS AND TRADERS (POSTHARVEST HANDLING AND GOOD MANUFACTURING PRACTICES REQUIREMENTS FOR MEAT ESTABLISHMENTS) ON SEPTEMBER 19-22, 2023 (REGION V), OCTOBER 24-27, 2023 (REGION IV-A) AND NOVEMBER 14-17, 2023 (REGION II)

In the exigency of service, the Agribusiness Industry Support Division (AISD) of the Agribusiness and Marketing Assistance Service (AMAS) will conduct a series of Technical Training to APTC/PTP Operators, FCAs/Farmers and Traders (Postharvest Handling and Good Manufacturing Practices Requirements for Meat Establishments). The trainings aim to: (a) Provide training on post-harvest handling for fruits and vegetables; (b) Provide the farmers and traders of high-value crop APTCs participants the basic principles of understanding postharvest handling and food safety; (c) Provide the participant APTC slaughterhouses/LGU operators the understanding on the requirements of good manufacturing practices; and (d) Provide the participants the opportunity for site visitation for an operational APTCs and be able to learn how the technical training capability could be applied in their respective APTCs.
