SUBJECT : AUTHORITY TO CONDUCT THE 1ST FARM AND FISHERIES CLUSTERING AND CONSOLIDATION (F2C2) PROGRAM 2023 NATIONAL CLUSTER SUMMIT ON 9-13 OCTOBER 2023 IN REGION IV-A

In the exigency of service, the DA-F2C2 Program is hereby authorized to conduct the 2023 National Cluster Summit on October 2023. The activity aims to further integrate, consolidate and mainstream clustering and consolidation into the Department of Agriculture Operating Units, Banner programs and Regional Field Offices, agriculture and fisheries stakeholders, Local Government Units, and farmer and fisher folk. Specifically, the cluster summit aims to:

1. Advance the interaction and condition of Filipino farmers and fishers to further adopt the strategy of clustering and consolidation;
2. Forge stronger linkages among farmers/fishers with other stakeholders in the agriculture sector;
3. Increase awareness to the Department of Agriculture's programs and how to avail of them;
4. Serve as a venue for potential buyers, market players and investors to interact with the F2C2 clusters; and
5. Further increase awareness and engagement to the F2C2 Program and clustering and consolidation.

Expenses to be incurred for the conduct of the Summit such as food and accommodation, honoraria for resource persons, kits, tokens, supplies, and materials, and other incidental expenses, shall be charged against DA F2C2 funds, as well as the plane tickets and traveling expenses for the Agri-Fishery Council representatives. While the traveling expenses and per diems of other participants shall be chargeable against their respective offices' funds, subject to usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall be considered revoked upon completion of the event. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
