The IFP Focal Person and Report Officer shall have the following functions:

1. Prepare the IFP Monitoring Forms and ensure timely submission to the Bureau of Agricultural and Fisheries Engineering (BAFE); and
2. Prepare and provide all necessary data/documents as requested by the BAFE.

The BAFE shall serve as the overall coordinator and secretariat of all Infrastructure Flagship Projects of the Department of Agriculture and shall be responsible in the consolidation and submission of the IFP Monitoring Forms to the National Economic Development Authority (NEDA) and furnish the same to the DA-Planning and Monitoring Service for their information and reference.

Travelling expenses, per diem and incidental expenses to be incurred by the Focal Person/Report Officer of the IFPs shall be chargeable against their respective office funds, subject to existing accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
