AUTHORITY TO CONDUCT MONITORING OF IMPLEMENTATION

OF EXECUTIVE ORDER NO. 39 SERIES OF 2023: IMPOSITION OF

MANDATED PRICE CEILING ON RICE

The monitoring activity shall be conducted daily from Monday to Sunday. As such, the above mentioned staff are hereby exempted from (a) regular official time of 8:00AM to 5:00PM and (b) using the biometric bundy clock. Further, they are entitled to compensatory time offsetting for work rendered during weekend.

The Personnel Division is tasked to use legally accepted means of monitoring the attendance of the aforementioned personnel while performing their functions (e.g. daily time records, log books, certificate of appearance, certification, etc.) on the completion of at least eight (8) working hours per day.

Further, the above mentioned staff shall be entitled to travelling allowance amounting to Php350.00 per day per staff or Php150.00 per day per staff if government vehicle is used relative to the monitoring of rice prices and other activities, chargeable against AMAS/OSEC funds, subject to fund availability and the usual government accounting and auditing rules and regulations.

This Order shall take effect on September 5, 2023 and shall be considered revoked upon the lifting of E.O No. 39, Series of 2023. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
