AUTHORITY TO CONDUCT AND PARTICIPATE IN THE 1ST SEMESTER ASSESSMENT OF PROGRAMS, PROJECTS AND ACTIVITIES FUNDED UNDER QUICK RESPONSE FUND (QRF) AND NATIONAL DISASTER

RISK REDUCTION AND MANAGEMENT FUND (NDRRMF)

The Department of Agriculture Disaster Risk Reduction and Management Section (DA DRRMS) is hereby authorized to conduct the 1st Semester Assessment of Programs, Projects and Activities (PPAs) funded under the Quick Response Fund (QRF) and the National Disaster Risk Reduction and Management Fund (NDRRMF) on September 25-29, 2023 in Davao City.

The activity aims to:

1. Reconcile the FYs 2019-2023 physical and financial accomplishment report of each OU as of August 31, 2023;

2. Discuss the implementation of different rehabilitation and recovery PPAs and revisit unaccomplished targets for different calamity fund implementation;

3. Assess and evaluate the performance of each OU on the implementation of PPAs funded under QRF and NDRRMF and submission of Catch-Up plans, if necessary

4. Draft initial plans and discuss 2024-2025 DRRM-related activities
