SUBJECT: DESIGNATIONS OF UNDERSECRETARY DEOGRACIAS VICTOR B. SAVELLANO IN COMMITTEES, TECHNICAL WORKING GROUPS, AND DEVELOPMENT PROJECTS RELATED TO LIVESTOCK, TOBACCO, AND BAMBOO

In the exigency of service, **UNDERSECRETARY DEOGRACIAS VICTOR B. SAVELLANO** is hereby designated as follows in committees, technical working groups and development projects related to livestock, tobacco, and bamboo, in addition to his designations in Special Order Nos. 986 and 1003, both Series of 2023:

- Chairperson of the Project Steering Committee in the implementation of Cooperative Threat Reduction Integrating Contract Phase of the Department of Agriculture-Bureau of Animal Industry;
- Chairperson of the Project Steering Committee, Project Management Group (PMG) for the Finalization/Packaging of the Livestock Inspection Safety and Enhancement Project Phase I (LISEP) for funding under KEXIM-EDCF;
- Chairperson of the Technical Working Group on Livestock and Poultry Statistics (TWG-LPS);
- Team Leader of the Project Preparation Team for the Crafting and Finalization of the Pandemic Fund Proposal on Livestock and Animal Health;
- Alternate Representative of the Department of Agriculture to the Inter-Agency Committee on Tobacco;
- Member, Executive Committee of the Philippine Bamboo Industry Development Council.

As such, he shall perform the functions, duties, and responsibilities inherent to the designations and such others as directed by the undersigned and the Secretary.

He shall be entitled to travelling expense, per diem and other incidental expenses that may be incurred in the performance of his functions, duties and responsibilities in view of the designations, chargeable against OSEC and other available funds, subject to existing government accounting and auditing rules and regulations.

All officials and employees of the Department, including its Bureaus, Attached Agencies and Corporations, and DA-Regional Field Offices are hereby advised of these designations and directed to give their full support and cooperation to Undersecretary Savellano in the performance of his duties and responsibilities.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked or amended.
