SUBJECT : AUTHORITY TO CONDUCT THE TRAINING ON THE PRDP MIS V.2.0 OR "SIDLAN"

The Systems Development and Management (SDM) sub-unit of the Monitoring, Evaluation, and Learning (MEL) Unit alongside with Progress Monitoring, Results Monitoring, and Knowledge Management, aims to improve the current web-based M&E system or the Management Information System (MIS) from the experiences gained by the PRDP through the years. Additionally, the updating of MIS is timely to fit the design of the PRDP Scale Up and the increasing demand for a real-time decision-making through prompt data collection and sound M&E analysis.

As such, a capacity building activity with other components and units will be held through actual simulation and encoding workshop of the major modules of the new PRDP MIS. The inputs and data to be encoded from the main users of the modules are needed as well as technical assistance from the PSOs and RPCOs MEL counterparts. Hence, the PRDP is hereby authorized to conduct the Training on the PRDP MIS v2.0 or "SIDLAN" on October 3-6, 2023 in the National Capital Region.

The objective of the activity is to capacitate key personnel who are involved in utilizing the enhanced version of the PRDP MIS. The expected outputs of the activity are as follows:

- Trained and capacitated end-users from PRDP National Project Coordination Office (NPCO), Project Support Office (PSOs), and Regional Project Coordination Office (RPCOs); and
- Encoded data sets for PRDP 2nd Additional Financing (AF2) and PRDP Scale Up
