AUTHORITY TO CONDUCT AND ATTEND THE LAUNCHING OF THE FISHCORE PROJECT AND SUPPORT MISSION AT FISHERIES

**MANAGEMENT AREA (FMA)-9** 

In the exigency of service and for the efficient and effective implementation of the FishCoRe Project, the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct the launching and support mission for the project on September 28-October 2, 2023 in Cagayan de Oro. The FMA-9 or the Bohol Sea is the Philippine's largest fishing ground encompassing 2,822,800 has and covering 5 different regions, 7,8,9,10 and 13, which includes a total of eleven (11) provinces and forty-nine (49) municipalities/cities.

The objectives of the activity are:

- 1. To launch the FishCoRe project with the World Bank Team at FMA-9;
- 2. Establish the institutional arrangement and project implementation structure at the FMA-9 level; and
- 3. Review and finalize the Work and Financial Plans, including the Procurement Plan.

The authorized participants inn the activity are the World Bank Team, BFAR-Central Office, BFAR Regionl Offices in FMA 9, academe, local government unit (LGUs), non-government organizations (NGOs), national governemtn agencies (NGAs), and representatives of the FMA-9 Management Board.
