AUTHORITY TO CONDUCT AND ATTEND THE NEEDS ASSESSMENT FOR AGRICULTURAL STAKEHOLDERS IN GEOGRAPHICALLY ISOLATED AND DISADVANTAGED AREAS (GIDA)
