**SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE ORIENTATION TRAINING-WORKSHOPS FOR ANIMAL WELFARE ENFORCEMENT OFFICERS (AWEOS) OF REGION VII**

In the exigency of the service and relative to the implementation of Republic Act No. 8485, otherwise known as the Animal Welfare Act of 1998, the Animal Health and Welfare Division of the Bureau of Animal Industry (AHWD-BAI) is hereby authorized to conduct the **Orientation Training-Workshops for Animal Welfare Enforcement Officers of Region VII**.
