SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE FY 2023 YEAR-END ASSESSMENT AND PLANNING WORKSHOP OF THE POLICY AND PLANNING OFFICE (PPO) OF THE DEPARTMENT OF AGRICULTURE

In the interest of the service and to ensure the effective and harmonious implementation of the activities of the Planning and Policy Office (PPO), the Planning and Monitoring Service (PMS) is hereby authorized to conduct the FY 2023 Year-End Assessment and Planning Workshop of the PPO in Region IV-A on December 18-20, 2023.

The general objective of the workshop is to assess the implementation of major activities of the PPO and to strengthen the coordination of its service units, as well as address implementation challenges encountered. Specifically, the workshop aims to:

1. Assess the FY 2023 performance of PPO service units;
2. Discuss the challenges encountered in the implementation of various activities and identify possible solutions to address these;
3. Present the FY 2024 plans of PPO service units; and
4. Discuss and identify strategies to harmonize and align the various activities and initiatives of PPO service units.

In this regard, participants listed in Attachment 1 are hereby authorized to participate in the said activity.

Expenses to be incurred during the conduct of the activity such as food, accommodation and incidental expenses shall be charged against PMS funds while travelling expenses and per diem of participants shall be charged against their respective offices' funds subject to the availability of funds and existing government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall be considered revoked upon the completion of the activity. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
