CREATION OF THE SUB-COMMITTEE ON FISHERIES UNDER THE NATIONAL COMMITTEE ON THE NETWORK OF PROTECTED AREAS FOR AGRICULTURE AND AGRO-INDUSTRIAL DEVELOPMENT (NPAAAD) AND STRATEGIC AGRICULTURE AND FISHERIES DEVELOPMENT ZONES (SAFDZ) TO STUDY THE FEASIBILITY OF ESTABLISHING A SAFDZ IN FISHERIES MANAGEMENT AREA (FMA) 4

In the exigency of service and to conduct of a study on the feasibility of establishing of a SAFDZ in FMA 4, a Sub-committee is hereby created comprising of the following:

The responsibilities of the Sub-committee shall be the following:

- 1. To study the feasibility of establishing a SAFDZ in FMA 4;
- 2. To conduct a technical assessment of the fishery resources and marine habitats in FMA 4
- 3. To consult concerned government agencies and experts, during the conduct of the study:
- 4. To review policy on declaring SAFDZ as economic zones;
- 5. To submit appropriate recommendations based on the study.

A Technical Working Group (TWG) is also hereby created to assist the Sub-committee to accomplish its responsibilities. The following shall compose the TWG and coordinate with National Mapping and Resource Information Authority (NAMRIA):

a. The Technical Group which will review literature on the bathymetry/depth at which aquatic life forms and marine habitats are located in specific areas. The said group shall be composed of:
