SUBJECT: AUTHORITY TO CONDUCT THE ELDERLY WEEK (SENIOR CITIZENS) SEMINAR FOR FY 2023

In the interest of service and to harmonize all services under the mandate and commitment of the Undersecretary for Special Concerns, the implementing office is hereby authorized to conduct the Elderly Week (Senior Citizens) Seminar for CY 2023 on October 27, 2023 in the Department of Agriculture-Central Office, with the theme **"Older Persons: Resilience in Nation Building"**.
