**SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE YEAR-END ASSESSMENT ON THE IMPLEMENTATION OF SMALL-SCALE IRRIGATION PROJECTS (SSIPS) UNDER DA BANNER PROGRAMS**
