SUBJECT

: AUTHORITY TO CONDUCT A SERIES OF ACTIVITIES IN CELEBRATION OF THE 60TH ANNIVERSARY OF CODEX ALIMENTARIUS COMMISSION (Codex@60) OF NATIONAL CODEX ORGANIZATION, OCTOBER 25-26, 2023

In the interest of service and in celebration of the 60th Anniversary of the Codex Alimentarius Commission (Codex@60), with the theme "Codex at 60: Continued partnerships for safe, affordable, nutritious, and sustainable foods through food standards", the National Codex Organization – Technical Committee (NCO-TC) is hereby authorized to conduct a series of activities starting October 2023, with culminating event on October 26-27, 2023, in the Food Development Center, Taguig City. The event shall be conducted in collaboration with the following Department of Agriculture – Food Safety Regulation Agencies (DA-FSRAs) and its attached agencies, and the Department of Health – Food and Drug Administration (DOH-FDA):
