SUBJECT

AUTHORITY TO CONDUCT AND ATTEND THE NATIONAL TRAINING ON DATA MANAGEMENT, MAPPING AND WEATHER DATA CORRELATION OF CORN PEST AND DISEASE INCIDENCE USING GEOGRAPHICAL INFORMATION SYSTEM (GIS)" IN MANILA ON NOVEMBER 6-10, 2023

As part of the Department of Agriculture's goal in promoting digitalization across agriculture specifically on corn pest surveillance and monitoring using developed surveillance systems and programs that incorporates validation, monitoring and mapping using Geographic Information System (GIS) to assess the current situation of major corn arthropod pest and diseases in the Philippines, the Bureau of Plant Industry-Crop Pest Management Division, is hereby authorized to conduct the "National Training on Data Management, Mapping and Weather Data Correlation of Corn Pest and Disease Incidence Using Geographical Information System (GIS)" (venue TBA) on November 6-10, 2023.

The training workshop is an opportunity for the participating agencies to learn about Geographical Information System (GIS), Mapping and software operation. Specifically, this activity aims to:

- 1. Provide trainees an Introduction to Basic Data Management which includes data cleaning and weather data processing/accessing;
- Introduction to Basic GIS with Quantum GIS (QGIS) that includes a workshop on creating a project using geo-processing, working with VECTOR and RASTER Data, Creating Basic Map, and importing CSV file into QGIS;
- 3. Status of Corn Industry in the Philippines;
- 4. Strengthen monitoring, surveillance and management system of insect pest and diseases of corn;
- 5. National Corn Pest status based on Corn Pest and Disease Management Information System (Online Database).
