SUBJECT:

CREATION OF THE NATIONAL STEERING COMMITTEE FOR THE LAUNCHING OF THE NEW WORLD BANK-FUNDED PROJECTS OF THE

DEPARTMENT OF AGRICULTURE

The Philippine Rural Development Project (PRDP) Scale-Up, the Mindanao Inclusive Agriculture Development Project (MIADP), and the Philippine Fisheries and Coastal Resiliency (FishCoRe) Project are three World Bank-funded projects of the Department of Agriculture (DA) that have been declared effective by the Bank's International Bank for Reconstruction and Development on August 23, 2023.

The PRDP Scale-Up and MIADP aim to increase agricultural productivity and resiliency, and significantly improve organized farmer and fisherfolk groups' access to markets and services. In particular, MIADP focuses on Indigenous Cultural Communities or Indigenous Peoples. Meanwhile, the FishCoRE Project prioritizes a comprehensive approach to fisheries governance, with a focus on the social and ecological dimensions of the Philippines Waters and its resources.

In view of the above, the Philippine Rural Development Project (PRDP) is hereby authorized to spearhead the launching of the World Bank-funded projects on November 8, 2023 in Metro Manila to create public awareness and officially start the implementation of the said projects.
