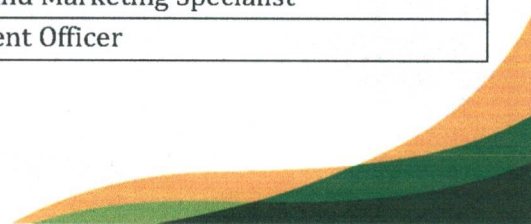
**SUBJECT : AUTHORIZED PARTICIPANTS IN THE TRAINING ON FASTMATCH TOOLKIT**

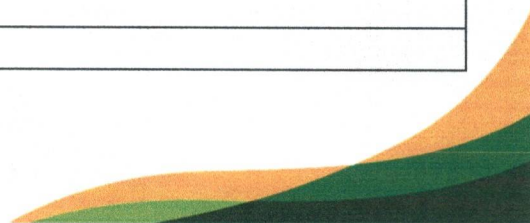
