2 officials sacked over onion deal

The Ombudsman on Friday dismissed two officials of the Department of Agriculture and the Food Terminal Inc. (FTI) over a questionable procurement of onions from a cooperative in 2022. Agriculture Assistant Secretary for consumer affairs Kristine Evangelista was cited for grave misconduct, while FTI vice president for operations John Gabriel Trinidad III got the boot for gross neglect of duty. -STORY BY JULIE M. DA, FTI officials sacked ver 2022 onion dea

The Ombudsman on Friday dismissed two officials of the Department of Agriculture (DA) and the Food Terminal Inc. (FTI) over the latter's questionable procurement of onions from Bonena Multipurpose Cooperative in 2022.

The Ombudsman dismissed DA Assistant Secretary for consumer affairs Kristine Evangelista for grave misconduct and conduct prejudicial to the best interest of the service, and FTI vice president for operations John Gabriel Trinidad III for gross neglect of duty and conduct prejudicial to the best interest of the service.

Their dismissal also included the cancellation of their civil service eligibility, forfeiture of retirement benefits and perpetual disqualification for re-employment in the government service.

In a 26-page resolution, the Ombudsman also junked the same administrative raps against DA Senior Undersecretary Domingo Panganiban, FTI president Robert Tan, DA Chief Accountant Lolita Jamela, DA Administrative Officer Eunice Biblanias and FTI budget division head Juanita Lu-

alhati were dismissed for insufficiency of evidence.

Criminal charges against the five said officials were also dismissed for lack of probable cause.

The administrative raps against Tan were dismissed as he will be a witness in the case.

Falsification of documents

The Ombudsman also recommended the filing of graft and falsification of documents charges against Evangelista, Trinidad, Bonena chair Israel Reguyal, Benedict Libres, Marlon Pagsisihan, Jocelyn Jane, Rossul Batadhay, Romy Jimeno, Charlito Ylanan, Francisco Laplana III, Arnold Osorio, Angelo Lajom, Randy Santos, Erickson Cortez, Ruben Bautista, Vince Lorenzo, Windell Glenn Canaan and AJ Bamala.

In late 2022, prices of red onions went up to P600 per kilogram from P180 per kg due to the shortage of red onions in the local market.

The DA's Agribusiness and Marketing Assistance Service then introduced the Kadiwa Food Mobilization Project in which agri-fishery commodities were directly brought to Metro Manila without going through middlemen and allotted P140 million for the project.

The DA entered into a memorandum of agreement with the FTI on a Kadiwa Food Hub project while the FTI also entered a deal with Bonena for the delivery of 8,845 sacks of onions at 28 kg per bag.

'Not corrupt'

But Evangelista maintained that she was "not corrupt" despite the Ombudsman's dismissal.

"Everyone I worked with knows I am not corrupt ... This can be proven by the farmers and other stakeholders with whom I have previously worked," Evangelista said in a statement sent to reporters.

Evangelista insisted that she was able to extend aid to farmers, farmworkers, vendors and consumers during her fouryear tenure.

"I believe that there is a solution to the food crisis we are facing and [the government] has the responsibility to implement programs to protect and serve every Filipino," she said.

"If we continue what we have started, we will be able to solve the food crisis," Evangelista added.

In December 2022, the price of locally produced red onions sold in Metro Manila soared to P380 per kg from P180 per kg in 2021. INQ



Shellfishes collected and tested from Sapian Bay (Ivisan and Sapian in Capiz; Mambuquiao and Camanci, Batan in Aklan); coastal waters of Pilar; President Roxas; Roxas City in Capiz; coastal waters of Gigantes Islands, Carles in Iloilo; coastal waters of Dauis and Tagbilaran City in Bohol; and Dumanquillas Bay in Zamboanga del Sur are still positive for Paralytic Shellfish Poison (PSP) or toxic red tide that is beyond the regulatory limit. Moreover, Lianga Bay in Surigao del Sur; and coastal waters of San Benito in Surigao del Norte are now positive for red tide toxin.



All types of shellfish and Acetes sp. or alamang gathered from the areas shown above are NOT SAFE for human consumption. Fish, squids, shrimps, and crabs are safe for human consumption provided that they are fresh and washed thoroughly, and internal organs such as gills and intestines are removed before cooking.

The following areas continue to be FREE from toxic red tide: coastal waters of Cavite, Las Piñas, Parañaque, Navotas, Bulacan, and Bataan (Mariveles, Limay, Orlon, Pilar, Balanga, Hermosa, Orani, Abucay, and Samal) in Manila Bay; mariculture areas in Infanta, coastal waters of Bolinao, Anda, Alaminos, Sual, and Wawa, Bani in Pangasinan; mariculture areas in Rosario, and Sto. 

Ombudsman orders filing of raps vs DA exec



Evangelista

The Office of the Ombudsman has ordered the filing of graft and falsification charges against suspended Department of Agriculture (DA) assistant secretary Kristine Evangelista, Food Terminal Inc. (FTI) vice-president for operations John Gabriel Benedict Trinidad III and 16 other individuals in connec-

tion with the alleged profiteering and price manipulation of onions late last year.

In a 26-page resolution, the dispositive portion of which was obtained by the media yesterday, the ombudsman said it found probable cause to indict Evangelista and Trinidad with violation of Section 3 (e) of Republic Act 3019 or the Anti-Graft and

Corrupt Practices Act and falsification of documents as defined and penalized under Article 172 of the Revised Penal Code.

Also ordered charged with Evangelista and Irinidad were 16 individuals from the DA, FTI and Bonena Multipurpose Cooperative: Israel Reguyal, Benedict Libres, Marlon Pagsisihan, Jocelyn Jane, Rossul Batadhay, Romy Jimeno, Charlito Ylanan, Francisco Laplana III, Arnold Osorio, Angelo Lajom, Randy Santos, Erickson Cortez, Ruben Bautista, Vince Lorenzo, Windell Glenn Canaan and A.J. Bamala.

The ombudsman, on the other hand, dismissed the charges against DA senior undersecretary Domingo Panganiban, DA administrative officer V Eunice Biblanias, DA officer-in-charge chief accountant Lolita Jamela, FTI president and chief executive officer Rob-

ert Tan and FTI Budget Division head Juanita Lualhati "for lack of probable cause."

"The resolution of this case is without prejudice to the conduct of fact-finding investigation against other public officers and private individuals responsible for the irregularities in the said project," the ombudsman's resolution read.

Meanwhile, in a separate decision also released yesterday, the ombudsman has ordered Evangelista's dismissal for administrative offenses of grave misconduct and conduct prejudicial to the best interest of the service.

Trinidad was likewise ordered dismissed for administrative offenses of gross neglect of duty and conduct prejudicial to the best interest of the service.

Aside from their dismissal, the ombudsman also imposed against them the accessory penalties of cancellation of civil service eligibility, forfeiture of retirement benefits and perpetual disqualification from holding public office.

The ombudsman said that in the event Evangelista and Trinidad are already separated from the DA and FTI, respectively, the dismissal is convertible to a fine equivalent to their salary for one year. The ombudsman said the fine "may be deductible from the respondent/s retirement benefits, accrued leave credits or any receivable from his/her office."

The ombudsman, on the other hand, dis missed the administrative charges agains Panganiban, Biblanias, Jamela and Lualhat due to "insufficiency of evidence."

The administrative case against Tan, mean while, was dismissed following the ombuds man's approval of his manifestation to become state witness and provide additional information relevant to the prosecution of the cases in court.

The ombudsman has yet to release to the media the full copy of its two rulings.

Ombudsman readies charges vs DA execs, private individuals in 2022 'onion mess'

The Office of the Ombudsman (OMB) is now preparing criminal charges that will be filed before the Sandiganbayan against Department of Agriculture (DA) Assistant Secretary for Consumer Affairs Kristine Y. Evangelista and 17 others over the shortage and spiraled prices of onion in 2022.

In a separate decision, the OMB ordered the dismissal of Evangelista and John Gabriel Benedict C. Trinidad III, vice president for operations of Food Terminal Inc. (FTI), for Grave Misconduct and Conduct Prejudicial to the Best Interest of the Ser-



vice, and Gross Neglect of Duty and Conduct Prejudicial to the Service, respectively.

"The principal penalty of dismissal from the service is imposed pursuant to Section 46(A)(1) and (3), Rule 10 of the Revised Rules on Administrative Cases in the Civil Service, and shall carry with it the cancellation of eligibility, forfeiture of retirement benefits, and perpetual disqualification for re-employment in the government service," the OMB said in its decision.

Dismissed

Meanwhile, all the criminal charges against DA Senior Undersecretary Domingo F. Panganiban, President and Chief Executive Officer Robert S. Tan of FTI, Chief Accountant Officer-in-Charge Lolita M. Jamela, Administrative Officer V Eunice F. Biblanias, and Budget Division Head Juanita G. Lualhati were dismissed for lack of probable cause.

The administrative charges against Panganiban, Biblanias, Jamela, and Lualhati were also dismissed for insufficiency of evidence. In the case of Tan, the administrative charge against him was also dismissed since he will be a witness in the case

Aside from Evangelista and Tan, also to be charged criminally were Bonena Multi-Purpose Cooperative representative Israel C. Reguyal, Benedict P. Libres, Marlon S. Pagsisihan, Jocelyn Jane, Rossul Batadhay, Romy Jimeno, Charlito Ulanan, Francisco V. Laplana III, Arnold Osorio, Angelo Lajom, Randy Santos, Erickson Cortez, Ruben Bautista, Vince Lorenzo, Windell Glenn A. Canaan, and AJ Bamala.

The OMB said that the DA monitored a recorded price increase in onions by the end of 2022, with prices ranging from ₱180 per kilogram to ₱600. The price increase was triggered by a shortage of supply of onions.

It said that to help, the government implemented the KADIWA Food Mobilization Project (FMP) worth ₱140 million, wherein agrifishery commodities from the production areas are directly brought to the National Capital Region (NCR) without going through middlemen.

It also said that the DA even implemented the FTI distribution hub, which would process and pack the agricultural commodities before going to the NCR.

But Ombudsman Samuel R. Martires, in an interview, said that the DA officials "manipulated the price of onions" when they left the purchase of onions to the FTI.

NIA partners with US firm for PH rice project

THE National Irrigation Administration (NIA) has partnered with Omstrom Climate Solutions Inc. for the development of a climate-smart rice project in the country.

Omstrom Climate, a
North American company
providing carbon management solutions, shall
provide funds for the
implementation of The
Climate-Smart Rice Project in Upper Pampanga
River Integrated Irrigation Systems (Upriis).

"The project is eyed for immediate implementation until December 2028 with the goal of contributing to the achievement of rice security and resiliency in

the country," NIA said on Thursday.

"This can be achieved by increasing water productivity in national irrigation systems while reducing carbon emission in irrigated rice cultivation," it added.

NIA Acting Administrator Eddie Guillen, Ostrom Climate President and Chief Executive Officer Phill Cull, and International Land Use Director Jane Boles signed the memorandum of understanding (MoU) for the project on Oct. 20, 2023.

The agency said the primary objective of the project is to promote a wide-scale and sustained adoption of alternate

wetting and drying technology in irrigated areas.

This will be done through Upriis with the provision of capacity-building activities and financial incentives with farmer partners.

For its part, Omstrom Climate will manage all fund releases for the project in accordance with existing government accounting and auditing rules and regulations.

It will also identify the required resources of the NIA Upriis staff participating in the project.

"With the signing of the MoU between NIA and Ostrom Climate, NIA looks forward to the realization of its vision of making the Philippines a climate-smart and climate change-resilient nation," NIA said.

The project is in line with the 7-Point Strategic Policy Agenda of NIA that falls under the Climate Smart Irrigators Association Farming System.

Other points of the agenda are irrigation infrastructure development, irrigators capacity building, management and governance, monitoring and evaluation, capability building of human resources, and strategic communication and advocacy.

NEDA boosts gov't, university collaboration on inflation policies

Academic institutions and government agencies should collaborate in creating technologies that acquire data on crops to help establish inflation policies, the National Economic and Development Authority (NEDA) said.

"The various technologies we discussed have significant potential to enhance our understanding, management, and policy-making for the agricultural sector," NEDA Assistant Secretary Reynaldo R. Cancio said during a conference

Participants from government agencies and universities shared the use of satellite images, drones, and artificial intelligence to generate agricultural data, such as crop planting areas, expected crop yields, and flood risk areas.

This information, NEDA said, may be used in monitoring the supply situation and outlook on agriculture.

NEDA, which chairs the Interagency Committee on Inflation and Market Outlook (IAC-IMO), has been exploring the use of satellite-based technologies to inform inflation management policy as it can deliver data quickly.

The IAC-IMO is tasked with formulating and recommending policies to bring inflation back on target and manage it more effectively.

Recommendations from this inter-agency committee are elevated to the Economic Development Group

for further discussions and endorsement to the president.

Meanwhile, another series of forums with technology developers is envisioned to develop a harmonized and streamlined arsenal of remotesensing technologies.

"We look forward to working together with all of you so that we can have a stronger and more advanced agricultural sector—a better Philippines where our fellow countrymen can enjoy a matatag, maginhawa, at panatag na buhay," Cancio said.

Earlier, multiple study visits were initiated by NEDA to explore technologies that can conduct rice and crop data through satellite images. (Xander Dave Ceballos)
