SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE 9TH NATIONAL ORGANIC AGRICULTURE (OA) MONTH CELEBRATION

Pursuant to the Presidential Proclamation No. 1030, issued on May 15, 2015, setting the month of November as the Organic Agriculture (OA) Month in the country to recognize the importance of organic agriculture and to encourage its adoption as an effective tool for development, environmental conservation, and health protection of farmers, consumers, as well as the general public, the Department of Agriculture (DA) through the DA-National Organic Agriculture Program (NOAP), DA-Agricultural Training Institute (ATI) and DA-Bureau of Soils and Water Management (BSWM) are hereby authorized to conduct the 9th National Organic Agriculture Month Celebration on November 10-12, 2023 at the Quezon Memorial Circle, Quezon City.

The said national launching aims to strengthen the organic agriculture industry in the country. Specifically, it aims to:

- 1. Increase the level of awareness of Filipinos on organic agriculture;
- 2. Showcase the research and technologies on organic agriculture;
- 3. Promote organic and naturally grown produce and products; and
- 4. Feature successful stories of organic agriculture practitioners.

As such, they are entitled to travelling expenses and per diem chargeable against their respective offices. All other expenses to be incurred in the conduct of the activity, including payment for the venue, food, rental of tents and equipment, service vehicles/transportation, exhibit materials, and other incidental expenses shall be charged against the organic agriculture funds of the DA-ATI, DA-BSWM, and the DA-NOAP, subject to the availability of funds and the existing government accounting and auditing rules and regulations.

This order shall take effect immediately and shall be considered revoked upon completion of the event. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
