AUTHORITY TO CONDUCT AND PARTICIPATE IN THE PILOT TESTING OF THE MODERNIZED PHILIPPINE GOVERNMENT ELECTRONIC PROCUREMENT SYSTEM

(MPHILGEPS)

Republic Act No. 9184 or the "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations (IRR) mandate that procurement process shall be simple and made adaptable to advances in modern technology in order to ensure an effective and efficient method and transparency. As such, the Philippine Government Electronic Procurement System (PhilGEPS) supports the implementation of Electronic Bid (e-Bid) Facility which will cover all types of procurement for goods, infrastructure projects and consulting services through electronic means. Further, the Government Procurement Policy Board (GPPB) issued Resolution No. 10-2022, "Conditionally Approving the Pioneer Implementation of the Electronic Bidding Facility in the Modernized PhilGEPS for Fiscal Year 2023".In pursuit of this, the Procurement Division is hereby authorized to conduct the Pilot Testing of the Modernized Philippine Government Electronic Procurement System (mPhilGEPS)" on December 4-7, 2023 in Region IV-A.
