**SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE WORKSHOP ON THE DEVELOPMENT OF BFAR CLIMATE CHANGE ADAPTATION AND MITIGATION-DISASTER RISK REDUCTION MANAGEMENT OPERATIONS MANUAL**
