DESIGNATION OF DA MONITORING AND EVALUATION (M&E) FOCAL PERSONS FOR THE PHILIPPINE DEVELOPMENT PLAN (PDP) 2023-2028

The designated focal persons from these Operating Units (OUs) shall have the following responsibilities:

- a.) Oversee the conduct of all monitoring and evaluation activities relative to the Department's commitments in the PDP 2023-2028;
- b.) In consultation with the concerned units within their respective offices, establish and flesh out the detailed information regarding PDP 2023-2028 indicators and targets such as the technical definition, methodology, disaggregation, timelines for data gathering and reporting, key assumptions and risks, and resource requirements, among others;

- c.) Ensure that all relevant PDP indicators and targets (national and regional level) are properly coordinated and disseminated to the management and all concerned units within the OU including regional counterparts, satellite offices, other contributing DA agencies, and other relevant stakeholders, as applicable;
- d.) Prepare and submit to the Planning and Monitoring Service Monitoring and Evaluation Division (PMS-MED) all PDP reportorial requirements requested by the National Economic and Development Authority (NEDA) for the Philippine Development Report (formerly Socioeconomic Report), Philippine Statistics Authority (PSA) for the Statistical Indicators on Philippine Development (StatDev), and other requirements of oversight agencies;
- e.) In coordination with their respective Neutral Evaluation Units (NEU), set out the priority evaluations to be pursued as a means of measuring and obtaining evidence on results derived from strategies and priority interventions laid out in the PDP;
- f.) Ensure that their respective OUs are on track towards achieving their committed targets in the PDP. In consultation with the management and concerned units, provide an analysis of the facilitating and constraining factors that affected the OU's performance, and prepare a catch-up plan, as needed; and
- g.) Serve as PMS-MED's point of contact for all M&E related activities and requests in relation to the PDP 2023-2028.

All officials and employees of the Department, including Bureaus, Attached Agencies and Corporations, DA Service Units and Regional Field Offices, are hereby advised of these designations, and are directed to give their full support and cooperation.

Traveling expenses, per diems, and incidental expenses of the designated focal persons in the exercise of their functions shall be charged against their respective offices, subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
