: AUTHORITY TO CONDUCT AND ATTEND THE CAPACITY BUILDING ON THE ROLL OUT OF THE REGIONAL AGRO CLIMATIC ADVISORY PORTAL (ACAP)

In the exigency of service, the DA Climate Resilient Agriculture Office (CRAO) in its implementation of the Adaptation and Mitigation Initiative in Agriculture (AMIA) is hereby authorized to co-organize "Capacity Building on the Roll Out of the Regional Agro-Climatic Advisory Portal (ACAP)" on November 20-23, 2023 in Sequoia Hotel Timog Avenue, Quezon City to be participated in by the regional Climate Information Services (CIS) teams.

As provided in Memorandum Circular No. 04, Series of 2020, the regular provision of weather-based farming advisories is one of the critical basic services of the DA Regional Field Offices. The ACAP is a digital platform for the generation and dissemination of climate-weather based farm and fishing advisories. It will serve as part of the local early warning system that will maximize returns on production input, minimize potential loss and damage and therefore result in higher productivity and income.

The objectives and expected outputs of the activity are:

- Understand the key concepts of Climate Information Services (CIS) and ACAP;
- Operate and manage the ACAP and its database for generation of different CIS products (for CIS Focal/Field Assistants);
- Customize and perform programming tasks related to ACAP software development, management, and maintenance (for Programmers).
