AUTHORITY TO CONDUCT THE 4TH QUARTER MEETINGOF FISHERIES MANAGEMENT AREA (FMA) 6 MANAGEMENT BODY (MB) AND SCIENTIFIC ADVISORY GROUP (SAG) AND WORKSHOP ON THE DRAFTING OF HARVEST CONTROL RULES AND HARVEST CONTROL MEASURES FOR PRIORITY FISH SPECIES IN MANILA BAY

In the interest to provide a science-based, participatory, and transparent governance framework and mechanism to sustainably manage and conserve our marine resources, the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct the 4th Quarter Meeting of FMA 6 Management Body (MB) and Scientific Advisory Group (SAG) and Workshop on the Drafting of Harvest Control Rules and Harvest Control Measures for Priority Fish Species in Manila Bay on November 28-30, 2023 in Region 3.

The activity aims to:

- 1. To get an update on the current status of FMA 6;
- 2. To report on the status of data consolidation and analysis to come up with top species with their respective indicators and proposed Harvest Control Rules (HCR) in Manila Bay;
- 3. To assess the relation between different types of Reference Points (RP) taking into account relevant factors such as the stock status and the exploitation patterns of different fisheries;
- 4. To provide an inventory of what types of harvest control rules (management procedures) will be proposed, tested or applied in identified key fish species;
- 5. To discuss how harvest control rules could be developed taking into account multispecies interactions and mixed fisheries;
- 6. To discuss a resolution on the adoption of the FMA 6 Framework Plan;
- 7. To present the Philippine Fisheries and Coastal Resiliency (FishCoRe) Project Components and Activities; and
- 8. To determine the criteria on the selection of target areas for FishCoRe Projects.
