**SUBJECT : AUTHORITY TO CONDUCT CAPABILITY BUILDING FOR NATIONAL MEAT INSPECTION SERVICE – REGIONAL TECHNICAL OPERATION CENTERS (NMIS-RTOCs) IN LUZON AND DA INSPECTORATE AND ENFORCEMENT (DAIE)**

In the exigency of service, the DA Inspectorate and Enforcement (DAIE) and National Meat Inspection Service- Meat Standards and Development Consumer Protection Division (nmis-MSDCPD) are hereby authorized to conduct capability building of personnel of NMIS-RTOCs in Luzon on December 5-7 2023 in Cordillera Administrative Region.

- a. Analyze trends and patterns in smuggling activities, and propose data-driven strategies to strengthen enforcement effort;

- c. Capacitate the enforcement unit to effectively execute programs that optimize the efficiency and effectiveness of food safety enforcement activities.
