**SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE PERSONALITY DEVELOPMENT AND COMMUNICATIONS TRAINING FOR VETERINARY QUARANTINE OFFICERS AND INSPECTORS AND ENFORCERS**

In the interest of service, the Veterinary Quarantine Service–Ninoy Aquino International Airport (VQS-NAIA) of the Bureau of Animal Industry (BAI) and the Office of the Assistant Secretary for Inspectorate and Enforcement are hereby authorized to conduct the **“Personality Development and Communications Training for the Veterinary Quarantine Officers and Inspectors and Enforcers of DA Regulatory Policies and Services”** on **February 6-7, 2024** (Batch 1) and **February 8-9, 2024** (Batch 2) at the **Animal Health Training and Information Center (AHTIC), Bureau of Animal Industry, Visayas Ave., Diliman, Quezon City.**
