This reassignment shall be operative for a period of one (1) year reckoned from the date of receipt hereof by each personnel. Upon the lapse of this period, restoration or return of each staff to their original post / assignment shall be automatic without the need of any order of restoration / revocation of his/her order of assignment. This shall be without prejudice to an earlier revocation of this reassignment by the Secretary.
