SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE FEEDBACKING WORKSHOP ON THE FY 2023 UPDATING OF THE DA'S PUBLIC INVESTMENT PROGRAM (2023-2028) AND THREE-YEAR ROLLING INFRASTRUCTURE PROGRAM (2025-2027)

In the interest of service and with the aim of strengthening policy making and planning of this Department, the PMS - Investment Programming Division (PMS-IPD) is hereby authorized to conduct a Feedbacking Workshop on the FY 2023 updating of the Department's Public Investment Program (PIP) 2023-2028 and the Three-Year Rolling Infrastructure Program (TRIP) 2025-2027 from March 11 to 15, 2024 in Region VII.

The activity aims to:

- Present the results of NEDA's validation of the Department's updated PIP/ TRIP;
- Provide a summary of priority Programs and Projects (PAPs) successfully funded under the FY 2024 GAA as proposed in the updated PIP and an assessment of proposed PAPs that were unfunded;
- Present to the concerned implementing units the regional allocation of investments for near-term PAPs, especially those proposed to be implemented under the FY 2025 budget; and
- Assess the PIP Updating process of the Department, discuss issues and challenges encountered, and determine areas for improvement.
