
The TWG shall perform the following functions:

- a. Formulate/review/update the Rice Extension Services Program and the corresponding implementing guidelines;
- b. Act as a steering committee to provide overall direction for the implementation of the RCEF-RESP;
- c. Monitor and evaluate the implementation of the program in coordination with the Philippine Council for Agriculture and Fisheries (PCAF);
- d. Coordinate with the DA agencies and other government partners
- e. Prepare plans and submit reports to the DA-RCEF Project Management Office; and
- f. Perform other tasks deemed relevant in the implementation of the RCEF-RESP.

All expenses of the individual members in the exercise of their functions shall be charged to the funds of their respective agencies, subject to the availability of funds and the usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda and other issuances inconsistent herewith are deemed revoked.
